CONSUMPTION OF ALCOHOL

CONDITIONS

GENERAL CONDITIONS

- 1. The Applicant must be over the age of 18.
- 2. The Applicant accepts responsibility in ensuring that only persons who are over the age of 18 consume alcohol.
- If alcohol is to be sold, permission must be obtained from the Department of Racing, Gaming and Liquor. A copy of the Liquor Licence must be
 provided prior to the Function/Event and if not the Shire will cancel the Function/Event without any further notice. All conditions on the Liquor
 Licence must be strictly adhered to.
- 4. The Applicant is responsible to control any anti-social behaviour by people attending the Function/Event.
- 5. The Applicant accepts full responsibility for any malicious damage that may be caused to the ground, equipment etc.
- 6. Security and safety measures will be undertaken to protect both Council property and members of the public.
- 7. Any disruption to neighbours is limited.
- 8. Unaccompanied juveniles are prohibited from entering or remaining on Council Property.
- 9. The Applicant must produce this permit on request to a Shire Ranger or Police Officer.
- 10. If any conditions are breached this permit is withdrawn immediately.
- 11. The Shire of Dardanup does not advocate or encourage the consumption of alcohol on Shire land.
- 12. The Applicant is not exempt from laws regarding the consumption of alcohol in public places enforced by the Police.

EATON HALL

13. Alcohol is only to be served and consumed inside the Eaton Hall. Drinking outside of the Eaton Hall is not permitted.

DARDANUP HALL

14. Alcohol is only to be served and consumed inside the Dardanup Hall. Drinking outside of the Dardanup Hall is not permitted.

DARDANUP SPORTING CLUB ROOM

15. Alcohol is only to be served and consumed inside the Dardanup Sporting Club Room. Drinking outside of the Dardanup Sporting Club Room is not permitted.

EATON FORESHORE

- 16. That parties must depart no later than midnight.
- 17. That the areas used must be left clean and tidy, with all rubbish being removed from the site.
- 18. The permit only applies to the Apex Park section of the foreshore area.
- 19. Vehicles are not permitted to be driven on areas within the rail fencing.

PUBLIC RESERVE

- 20. That parties must depart no later than midnight.
- 21. That the areas used must be left clean and tidy, with all rubbish being removed from the site.

EATON RECREATION CENTRE

22. The Duty Manager reserves the right to close the Party/Event if any conditions are breached.
