"In carrying out its functions a local government is to use its best endeavours to meet the needs of current and future generations through an integration of environmental protection, social advancement and economic prosperity".


Our Vision

The Integrated Planning Framework, introduced by the Western Australian State Government in 2012, requires each Local Government to have a Strategic Community Plan, a Corporate Business Plan and other informing strategies in place to ensure the future provision of services is sustainable



Sustainability Charter 2021-2031



- Charter outlines guiding principles and overarching objectives linked to the 5 pillars .
- The aim is use it as mechanism to report against key performance indicators to demonstrate the Shire's commitment to sustainability once developed.
- Sustainability in this context means balancing economic, social and environmental factors and setting out key facilities & services priorities for the future.
- This Sustainability Charter sets out the ways in which the Shire will exercise the range of its functions and use its best endeavors to meet the needs of current and future generations through an integration of the five pillars.

Five Pillars:



ENVIRONMENTAL PROTECTION

Demonstrate responsible custodianship of the land, water, air and built environment by managing and developing key strategies to preserve, protect and enhance the environmentally sensitive and natural areas and eco systems for current and future generations.



ECONOMIC PROSPERITY

Valuing the local economy focusing on the key strengths and opportunities by optimising sustainable investment through promoting the region as a desirable place to visit, work invest and do business.

SOCIAL ADVANCEMENT

Enabling the community to meet its own needs, advance their potential and improve well-being through healthy, safe and fulfilling lifestyle choices and valuing our community's cultural knowledge and sharing this with future generation.



SUSTAINABLE FACILTIES AND SERVICES

Embrace the role of a leader in the community by supporting Sustainable or Green Infrastructure & Transport opportunities that aims to limit the reliance on diminishing natural resources that leave a high carbon footprint.



SUSTAINABLE MATERIALS

Embrace the role of a leader in the community by supporting and promoting the use of emerging sustainable materials and products aiming towards a limited negative impact on depleting or degrading the natural resources and environment.

Sustainability Frameworks



- WALGA, the City of Perth and Murdoch University has reviewed and made a comparative analysis of 5 Sustainability Frameworks.
- Should the Shire want to pursue a Sustainability Framework for benchmarking purposes there are several that may be considered for this purpose, i.e. One Planet Living, The Natural Step, UN Sustainability Goals, Green Star Communities and Transition Dynamics.
- These frameworks need extensive resources and is mostly developed and supervised by external peak bodies or companies.
- In a local government context the assessment of the frameworks had a particular emphasis on Capital Cities. The key criteria for the analysis was:
 - Alignment and Potential Integration with key city strategies/ approaches (user friendly)
 - o Financial costs
 - Resources (FTE)
 - Benchmarking Opportunities (if so, what level)

 Effective Communication Tool? Internal (Corporate) or External (community)

Shire of Dardanur

- Alignment and Integration potential with other frameworks
- Ability to Demonstrate Leadership (Local, National, Global)
- Ability to use a Transition Tool (Staging Approach)

Sustainability Frameworks

SO WHAT DOES THIS ALL MEAN?

- No one sizes fits all approach
- Frameworks allow to go beyond a status quo approach
- Local Governments want to share knowledge and benefit from synergies

Making it work for local government and its communities

- A shared vision internally and externally (engagement is important)
- Optimistic yet doable, easily communicated targets (with matching indicators data)
- Consistency of data sources)
- Clear, replicable reporting processes
- Consider the length of action plan
