<b>(BA2 form)</b> Uncertified Building Permit Application <b>Class 1 or 10 only</b> (Dwellings, residential sheds & patios, private swimming pools, retaining walls, signs, masts, etc.) <b>SHIRE TO ISSUE BA3 (CDC) Certificate of Design Compliance inclusive.</b>	<b>0.32%</b> of the estimated value (inclusive of GST) of the building work as determined by the relevant permit authority, <b>but not less than \$105.00.</b> <b>N.B. This permit authority certification service is for Shire of Dardanup issued permits only.</b>
<b>(BA1 form)</b> Certified Building Permit Application <b>Class 1 or 10 only</b> (Dwellings, residential sheds & patios, private swimming pools, retaining walls, signs, masts,) <b>with BA3 (CDC) Certificate of Design Compliance supplied.</b>	<b>0.19%</b> of the estimated value (inclusive of GST) of the building work as determined by the relevant permit authority, <b>but not less than \$105.00.</b>
<b>(BA1 form)</b> Certified Building Permit Application <b>Class 2 to 9 only</b> (Commercial and Industrial) <b>with BA3 (CDC) Certificate of Design Compliance supplied.</b>  <b>Option; Permit Authority to supply BA3, available within the Shire of Dardanup BAO. (council set fee) = \$165.00 p/h</b> Check with Principal Building Surveyor prior, as limited resources available in certifying class 2 to 9 buildings. (Commercial and Industrial)	<b>0.09%</b> of the estimated value (inclusive of GST) of the building work as determined by the relevant permit authority, <b>but not less than \$105.00.</b>  <b>\$165.00 per hour. N.B. This limited certification service is only available for small developments within the Shire of Dardanup and is charged at an hourly rate. (Independent certification is encouraged for class 2 to 9 buildings.)</b>
<b>(BA5 form)</b> Application for Demolition Permit	<b>\$105.00</b> for class 1 and 10 only. <b>\$105.00</b> for each storey of a class 2 to 9 building.
<b>(BA22 form)</b> Application to extend the time during which a building or Demolition Permit has effect.	<b>\$105.00</b>
<b>(BA9 form)</b> Application for an Occupancy Permit for a completed building.	<b>\$105.00</b>
<b>(BA9 form)</b> Application for a temporary Occupancy Permit for an incomplete building.	<b>\$105.00</b>
<b>(BA9 form)</b> Application for modification of an Occupancy Permit for additional use of a building on a temporary basis.	<b>\$105.00</b>
<b>(BA9 form)</b> Application for a replacement Occupancy Permit for permanent change of the building's use or classification.	<b>\$105.00</b>
<b>(BA15 form)</b> Application for Occupancy Permit (class 2 to 9) or Building Approval Certificate (class 1 and 10) for registration of strata scheme, plan of re-subdivision.	<b>\$11.60</b> for each strata unit covered by the application, <b>but not less than \$115.00</b>
<b>(BA9 form)</b> Application for Occupancy Permit (class 2 to 9) for a building in respect of which <u>unauthorised work</u> has been done. (Must include a BA13 form and associated fee.)	<b>0.18%</b> of the estimated value (inclusive of GST) of the unauthorised work as determined by the relevant permit authority, <b>but not less than \$105.00</b>
<b>(BA13 form)</b> Application for Building Approval Certificate for a building in respect of which <u>unauthorised work</u> has been done. (Certified application to include a BA18 form.)  <b>(BA13 form) also applies for a change of classification or use to some buildings with existing authorisation.</b>  <b>Option; Permit Authority to supply BA18 including an inspection certificate report BAO, available only within the Shire of Dardanup. (council set fee) = \$165.00 per hour.</b>	<b>\$0.38%</b> of the estimated value (inclusive of GST) of the unauthorised work as determined by the relevant permit authority, <b>but not less than \$105.00</b>  <b>Fee of \$105.00 applies</b>  <b>Shire supply (BA18) = \$165 per hour.</b>
<b>(BA23 form)</b> Application to extend the time during which an Occupancy Permit or Building approval certificate has effect.	<b>\$105.00</b>
<b>Application for Amendment to a Building Permit, BA1 form with BA3 supplied or BA2 form for permit authority to include BA3 (CDC) Certificate of Design Compliance.</b>	<b>Same calculation as Application for Building Permit, (BA1 or BA2) based on change to contract value only, but not less than \$105.00</b>
